

# *Get Educated, Get Enrolled* NMHA's Medicare Rx Benefit Campaign

November 4, 2005

#### Welcome

The National Mental Health Association is a leading voice in ensuring that the scope and implementation of the Medicare Rx benefit meets the needs of beneficiaries with mental health disorders, particularly those who are dual eligibles. To help consumers and advocates with the approaching enrollment period, NMHA has created the "*Get Educated, Get Enrolled*" Medicare Rx Benefit Campaign. ## Countdown

### **Important Notes!**

If you are a Medicare beneficiary or you work with consumers, the following information is important to keep in mind while you review and choose a Medicare prescription drug plan. If you are unfamiliar with private insurance, you should find the definitions below helpful in understanding your new Medicare drug coverage.

Plan Information

- Medicare drug coverage generally will **not cover** the following types of medications: barbiturates, benzodiazepines, over the counter medications, prescription vitamins, drugs to treat anorexia, and weight loss or weight gain drugs. Enhanced benefit drug plans *may* cover some of these medications, but again, you will have to pay some of your premium payment per month, if you get *Extra Help*.
- If you currently take a benzodiazepine (e.g. Ativan, Klonopin, Xanax, Valium), *some* Medicare prescription drug plans may cover this type of medication (these plans are called enhanced benefit plans) even though they are not required to b the Medicare law. If you get *Extra Help*, and you choose a plan that covers benzodiazepines, you will have to pay some of your monthly premium payment, since Extra Help only covers basic benefit plans and <u>not</u> enhanced benefit plans. **Many state Medicaid programs plan to continue covering benzodiazepines, so if you are currently enrolled in Medicaid and take this type of medication, you may still be able to get it. Contact your Medicaid office for more information.**

<u>Are you currently enrolled in a manufactured patient assistance program?</u> If you currently get your medication(s) through a patient assistance program, you will not be able to continue in this program and sign up for Medicare drug coverage. This is true even if the

Medicare prescription drug plan you sign up for does not cover the prescription medication you

### Important Definitions to Remember

**Copay Tiers** – Copay tiers allow the prescription drug plans put different copayment amounts on different types of medications. Older medications are generally in a lower, less expensive tier, than newer, more expensive medications. The tiered structure is often the following generics (lowest copay), preferred brand name drugs, non-preferred brand name drugs (highest copay).

**Prior Authorization** – A cost-control procedure in which a plan requires that a prescription medication is approved for coverage before it may be given to the patient. This usually means that a physician must sign and fax a "prior authorization form" to the plan with proof that the medication is necessary before the patient may fill his/her prescription.

**Step therapy** – Step therapy (also known as fail-first requirements) is used when there are multiple drugs available for treatment of a specific condition. Step therapy requires the use and failure of one drug, typically the oldest, least costly drug, before a newer, more costly drug will be covered.

## NASMHPD Long Term Care Guidance
